Moodle Developments:

Students are able to connect to the Libraries directly through York's Moodle LMS. In addition, faculty can use Moodle to include subject librarians in courses. In addition, students can access Virtual Reference Service via Moodle.

AIF Project # 1:

The SPARK project – Student Papers and Academic Research Kit – (formerly known as the Virtual Learning Commons) will be launched in September 2013. This online resource will encompass research, writing, and learning skills directed to the needs of undergraduate students from across a range of disciplines, including direct entry, mature, and international students.

AIF Project # 2:

The Libraries and Counseling & Disability Services received additional funding in Winter 2013 to further develop videos to promote accessibility services and instruct students on how to use Kurtzweil and other tools.

AIF Project #3:

YUL was provided funds in Winter 2013 to provide an online learning module in 2013/14 which would assist Faculty in teaching and students in understanding the issue of plagiarism.

Sarah Coysh, the head of the Frost Library, was a member of the YU E-Learning Steering Committee and developed a business plan to further develop library e-learning supports.

1.1.4 Position the library as a center of intellectual inquiry and community engagement

Plans are underway to develop a French Virtual Reference Service for students which will particularly benefit students at Glendon College. This service will be part of OCUL's collaborative Virtual Reference Service is available 323 hours a week, and York has the heaviest usage amongst its OCUL partners.

The Undergraduate Research Fair was held in February 2013 and was a huge success. A total of 90 eligible students submitted their papers to this year's Research Fair. A total of 37 papers were accepted by the Fair. Almost 300 people attended the fair. Plans are underway to repeat this event in 2014 and more faculties will be invited to participate in the Research Fair.

Informal learning opportunities in the Library included:

- The open debate, "Should the blog replace the book"
- the Steacie "Hackfest" on February 21, 2013
- The Gustav Klimt art exhibit, that was prepared in conjunction with the Austrian consulate
- A photo exhibit on life in the Philippines during the period when martial law was in effect
- The HASTACK reception for digital humanities
- The lecture by Bora Zivkovic on "Science in New Media Ecosystems" which was hosted by the Libraries at Bethune College
- Jen Bervin, a poet and artist, gave two talks in the Scott Library on March 5 and 6, as part of the Creative Writing Reading Series.
- A Data Mining Workshop, "How to Build a Macroscopic" was held in the Library on March 15.

2.2.1 Build excellent 21 Century library learning spaces



A total of 50 new study spaces were created on the 2nd floor of the Scott Library this year in space previously occupied by the Scott Reference department. The total number of student study spaces in YUL has increased to 1,640 as a result of this project.

The Library also completed Phase 1 of renovations on the 1st floor of the Frost Library at Glendon campus. These renovations were the first major upgrade to the premises in 60 years. Phase II is under way with financing provided by monies from a Library trust account.

2.2.2 Create dynamic community engagement spaces in our libraries.









Research Celebrations for the Faculties of Environmental Studies and Health were held in the Scott Library this year.

The Library's new Communications Officer is actively supporting York University Libraries' twitter account. The number of followers increased 52% in one year, and the re-tweet rate is 81.7%.

The Portuguese and Greek communities are collaborating with the Clara Thomas Archives and Special Collections department to collect, digitize, archive, and make accessible over the web, their Canadian Heritage holdings.
